### Invoice Submission and Tracking

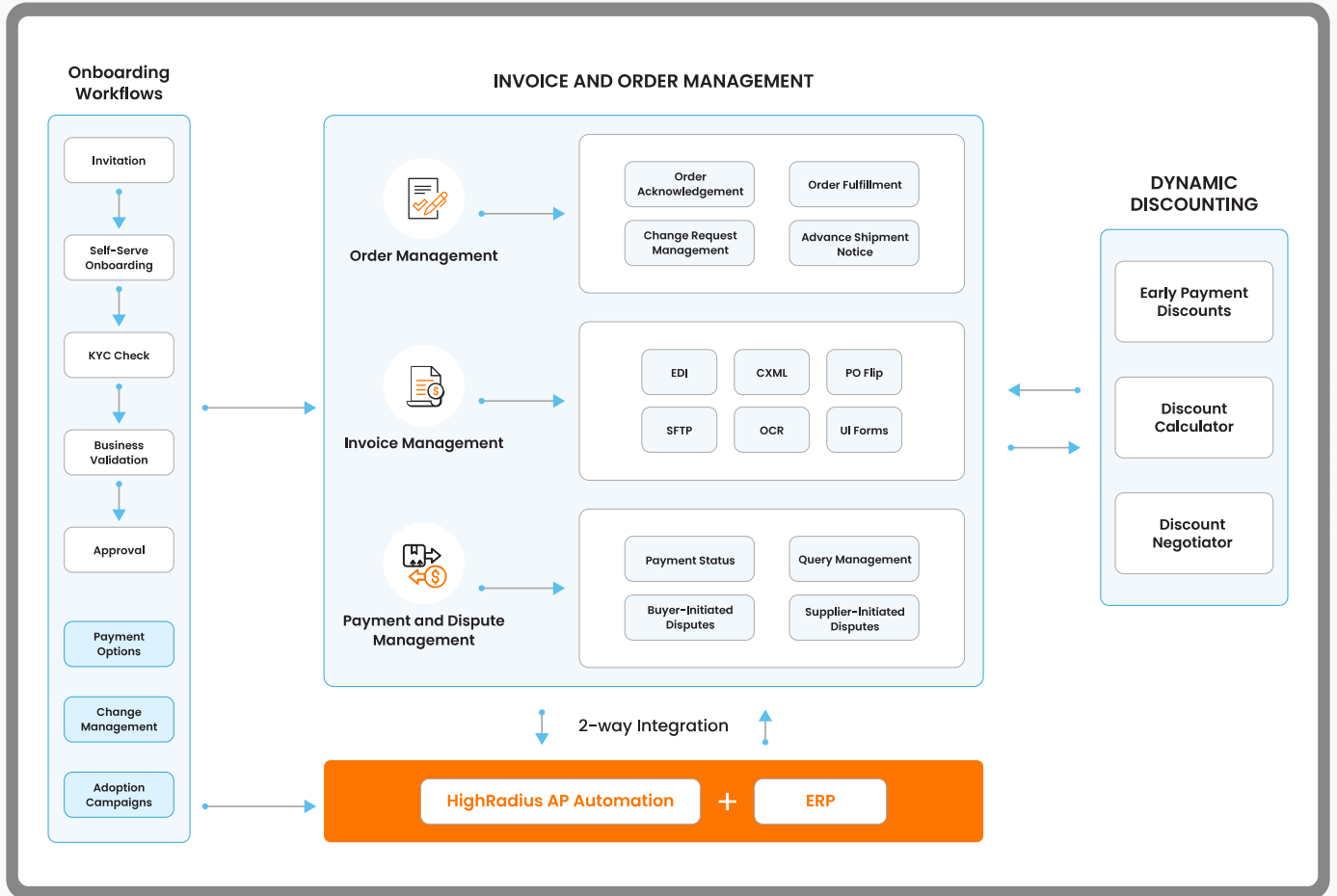
