The Challenges

Managing Internal Cash Movements Effectively

Internal transfers between accounts often depend on spreadsheets and manual inputs across disconnected systems. This lack of automation delays execution, limits real-time cash visibility, and increases the risk of misallocation especially when managing liquidity across multiple entities.

Handling Complex Treasury Disbursement Workflows

Cross-border payments, POBO setups, and treasury disbursements often rely on manual entries and approval chains. This makes it difficult to maintain control, meet cutoffs, and reduce processing times. High dependency on human input adds operational risk in high-value transactions.

Tracking Payment Status in Real-Time

Payment acknowledgments and status updates from banks are not always synced with internal systems. This delays exception handling and increases the time spent manually reconciling payments resulting in blind spots in payment tracking.

Automating Bulk Vendor Payment Processing

Bulk vendor payments typically involve manual ERP file uploads, formatting for multiple banks, and fragmented status tracking. These steps slow down the process, introduce reconciliation errors, and require excessive analyst intervention making it difficult to scale payments during peak periods.

Generates payments directly from financial instrument cash flows, reducing manual oversight and ensuring timely settlement across entities.




